



#### Azmah Arzmi Early Stage Researcher

I was in Cyprus for the ISUF Conference in Nikosia in the first week of July this summer. I booked a flight to Ercan airport, not knowing that it was North Cyprus, which is occupied by Turkey. It just seemed closer to Nikosia than Larnaca was. Then I was told after I booked the flight, that it was illegal to land in North Cyprus and that I could not enter the 'real' Cyprus. Nevertheless, I managed to get to Lefkosa, cross the border to Nikosia without a fuss and managed to attend the conference. I explored both sides of the divided city and visited the buffer zone, learning about the history of the militarized conflicts. I compared this conflict in parallel with the history of divided

Berlin, although the Turkish Cypriots have more freedom of crossing the border and working in the 'actual' Cyprus and the wall and checkpoint were not so dangerous. I went back to North Cyprus again because I was intrigued and wanted to explore the Turkish part, plus it was much cheaper. So I explored Kyrenia, the northern coast and also visited Famagusta. I enjoyed visiting the historic sites and going on tours with the conference participants. Anyone who's a history buff on Greek, classical and Ottoman history would enjoy exploring the country(ies). Buses and meals were cheap in North Cyprus and there were a myriad of British tourists on the Turkish side. Much to the irk of the border guards, I returned to the 'real' Cyprus again and went to Larnaca, spent a weekend at the beach before taking the flight back from Larnaca airport. The officer was not happy that I entered through Ercan and just wanted to scare me by making me wait for a while but the other officer let me off, scot-free. Would I do it again? Sure, my passport doesn't restrict me from going to both countries visa-free but I would probably spend more time in North Cyprus because the guards seemed less uptight and the people friendlier (besides the fact that it is much cheaper now with the Turkish economic crisis).












